I. Call to Order

07/20/2020

Chair Borgeson called the meeting to order at 9:03 a.m. and stated that the meeting was being conducted in compliance with Nebraska's Open Meetings law, a copy of which is located on the back wall.

Chair Borgeson called the Roll at 9:04 a.m. Chair Borgeson, Vice Chair Duda, and Trustee Rodgers were present for the meeting. Trustee Cavanaugh, Trustee Kraft and Trustee Morgan called in and were present online. Trustee Boyle was absent.

II. Consent Agenda

Chair Borgeson announced at 9:04 that there was not a quorum in the room so they will not be able to approve the item on the Consent Agenda. It will be added to the agenda for the next meeting.

III. Citizen Comments

Chair Borgeson called for members of the audience to be heard regarding any item not on the agenda. No questions or comments were presented.

IV. Action

No items on the agenda.

V. Discussion

a. COVID-19 i. DCHC (Erin Nelson) Speaking is Erin Nelson.

Ms Nelson's presentation was included in the packet distributed and is attached to these minutes. She reviewed new guidelines by the CDC for retesting of residents who previously tested positive. Nebraska Dept of Health and Human Services (NHHS) will be distributing point of care tests to all long term care facilities in September and results should be available in about an hour.

Ms Nelson also reported that the Dreamweaver Foundation in Omaha donated 100 Facebook portals for residents to be able to stay in touch with families; the donation is worth approximately \$20,000.

The Reopening Phases were reviewed.

Ms Nelson reviewed the census trend from December through today. If the facility can stay COVID free for twenty-eight (28) days, new admissions can be accepted around the beginning of August.

An update on the Cares Act funding was provided; Phase 1 includes Facility Capital and Operational Improvements. Ms Nelson gave an overview of the improvements in each category.

Ms Nelson and the DCHC Dietary staff determined, with the onset of the pandemic, that their setup and service was not providing residents with the best dietary experience. Ms Nelson reviewed the process they used to identify upgrades and modifications needed to the current system. These changes will include a menu choice for residents and the ability to keep food warm when served for individual dining. There will be no positions eliminated with this new plan. This conversion will take approximately 10 months. The details are provided in the presentation.

ii.CMHC (Sherry Glasnapp) Speaking is Sherry Glasnapp, Trustee Cavanaugh and Trustee Rodgers.

Ms Glasnapp reviewed the Phase One process for opening Day Treatment which is detailed on the slide included with this presentation.

iii.GA Primary Health Clinic (Melissa

She was proud to announce that the State has approved the accreditation with the criminal justice standard. She thanked the Board for the support and advocacy during the process.
