1. Intensive Speaking is Mike Phillips. Outpatient

Program Mr Phillips provided an update on the Intensive Outpatient Program (IOP) and how they are Update (Mike modifying the program with the current COVID crisis. He reported that two (2) therapists and Phillips) two (2) former clients were asked to participate in a webinar for the University of North Carolina-Chapel Hill; the program continues to go well in spite of COVID. Staff continues to work toward using the Second Chance ACT grant to duplicate the IOP that's set up on the secure side of Corrections.

VI. DCHC/CMHC Routine **Reports & Updates**

Admin Update

Ms Nelson reported that the Fire Marshall conducted a Life Safety Survey at the end of July; only four (4) deficiencies were found and have been corrected. The Federal/State survey was conducted from July 27 through July 30 with minimal low level tags identified. A Plan of Correction has been implemented and provided to the State.

Ms Nelson also reviewed the projects being funded by the Cares Act. Contractors are currently onsite working on Phase 1 which includes renovation of the lobby, addition of an intake area, addition of a Pharmacy window accessible outside the building and the addition of overnight rooms; Phase 2 includes the remodeling of the whirlpool rooms, the addition of isolation rooms in the Cavanaugh Center, new air handlers/chillers and installation of touchless faucet. With the Provider Relief Funds, new medical and therapy equipment, a transport bus, a visitor tracking system, staffing software, Sonifi channels and N95 fit testing equipment have been purchased.

Ms Nelson informed the Board that DCHC has maintained its 5 star rating with CMS.. There was a brief discussion about the rating system.

c. **Staffing Report** Ms Glasnapp informed the Board that a current employee will be transferring to the Day Treatment Program. This change will take the program to the next level as they work with the new Psychiatric Emergency Services (PES) facility at UNMC.

d. **Workload Report** Ms Glasnapp gave a brief report. She added that the outpatient will be working with the PES once it opens. Getting clients in for appointments, therapy, day treatment and receiving medications will reduce hospitalization as the PES. With the Cares Act funds CMHC is receiving, they will be developing a telehealth program.

d. Medication **Distribution Report**

Ms Glasnapp gave a brief review of the report.

VIII. Adjourn Trustee Boyle motioned to adjourn the meeting. The motion passed and the meeting was
