I. Call to Order

Chair Borgeson called the meeting to order at 9:01 a.m. and stated that the meeting was being conducted in compliance with Nebraska's Open Meetings law, a copy of which is located on the back wall.

Chair Borgeson called the Roll at 9:02 a.m. Chair Borgeson, Vice Chair Duda, and Trustee Rodgers were present for the meeting. Trustees Boyle, Cavanaugh and Kraft called in and were present online. Trustee Morgan was not present.

II. Consent Agenda

Chair Borgeson acknowledged there was not a quorum present so the Consent Agenda would not be approved at this time. An emergency Board Meeting will be scheduled on Tuesday, October 27, 2020 at 9:00 a.m. before the Board of Commissioners meeting. The items on the Consent Agenda will move to that meeting.

III. Citizen Comments

Chair Borgeson called for members of the audience to be heard regarding any item not on the agenda. No questions or comments were presented.

V. Discussion

a. COVID-19 Update

i. COVID-19 Update (DCHC)

Speaking is Erin Nelson.

Ms Nelson presented a slideshow for her COVID update. She provided an update on the current number of cases in DCHC and the statistics on the rapid antigen testing started on September 17th. She explained the shift to twice a week testing for all staff due to the community positivity increase. Ms Nelson explained that the test results are reported to the CDC National Healthcare Safety Network (NHSN) and the goals of the NHSN. She also noted that hospitals have been required to do this for 30 years; Nursing Homes have recently been required to report.

Ms. Nelson provided NHSN data from May 24, 2020 to October 4, 2020 for various nursing homes in the community of the number of COVID cases per location and the number of beds available vs beds occupied.

Ms Nelson announced that we are currently in Phase 2 of the CMS Reopening of Nursing Homes. She described the activities that are occurring with the residents during this phase and the obstacles involved in moving to Phase 3. Staff is looking for ways to onboard nursing staff quicker.

She detailed the cost of testing staff with the rapid antigen testing; there are additional provider relief funds available for these expenses.

She gave an update on the projects that are funded by the Cares Act money.

Data was provided for admissions from this time last year to date including discharge/deaths and percentage of occupancy.

Ms Nelson reported that the Dietary staff are using the new heat retention tray system in all units. The next step will be to upgrade the menu for more choices for the residents and bring the program up to 2020 standards.

Ms Manning presented a staffing report which included turnover, onboarding, agency shifts, mandated shifts and FTE's compared to last year. She added that Molly O'Neil (Motsinger) is working on a marketing recruitment for CNA's. Ms Manning acknowledged that we are getting applications for CNA's but they have decreased because of pandemic.
