Ms Nelson provided a presentation for her Admin Update. She provided statistics regarding cases and history. The vaccine will be provided in the new couple of weeks; DCHC will be receiving the Moderna vaccine.

Ms Nelson provided an update on the Cares Act and included photos of the UVC robot, the remodeled DCHC front lobby and the addition of air handlers in this area to provide a more consistent temperature in this area, the new whirlpools, and the air handlers to the facility. She explained the importance of the new air handlers as so many things like the flu and tuberculosis are carried through the air and they should prove invaluable in the future. Also included were the new Pharmacy walkup window, stay over rooms for staff shortages and touchless faucets for infection control.

Ms Nelson reviewed admissions and the current census. As more of the public as well as the residents receive the vaccine, these numbers should increase.

She also announced that in honor of Vice Chair Duda and Trustee Kraft for their many years of service to the County and their support of the DCHC, the DCHC gift shop will be renamed the Kraft General Store and the pavilion will be named the Duda Pavillion.

b. Finance Report
