I. Call to Order

Chair Borgeson called the meeting to order at 9:01 a.m. and stated that the meeting was being conducted in compliance with Nebraska's Open Meetings law, a copy of which is located on the back wall.

II. Consent Agenda

V. Discussion

a. Detoxification Services CARF Review Results Teri Speck is speaking.

Ms Speck gave an overview of the Commission of Accreditation for Rehabilitative Facilities (CARF) program and the COA. She noted that it will now include the civil protective custody program. The survey was held virtually from May 24-26. This is the second CARF review since the Detox program has been with Douglas County. The standards in 4 different sections; leadership, programming, core programs and core support standard for civil protective custody program. The Zone system that was developed by staff played a big role in receiving such a successful review. There were 1596 standards to meet for a perfect survey. There were no recommendation which is the best review possible and rarely achieved. The official report will be received in 6-8 weeks and staff expects to receive 3 years with no recommendations. The board members acknowledged what an incredible job the staff has done with the program and the accreditation.

VI. DCHC/CMHC Routine Reports & Updates

a. Admin Update

Erin Nelson is speaking.

Ms Nelson provided a presentation. She reported DCHC is in Phase Three which includes inroom visits with vaccinated family members, return of church services, large group dining and family and facility outings. She reported the vaccination rate and the outbreak guidelines if an employee would test positive. Staff is focusing on creating the home–like environment the residents enjoy and are planning a 4th of July outdoor celebration on Wednesday, June 30th.

Ms Nelson provided a census overview comparing the statistical data of ages, sex and general type of diagnosis of the DCHC residents. The staff will focus on building relationships with the VA, ACO Network, Geri-Psychiatrist and hospice providers. The new dietary system is expected to be implemented in January.

b. Recruitment Update

Molly O'Neil is speaking.

Ms O'Neil provided a presentation addressing the difficulty staffing for CNA's and CMA's at DCHC. She highlighted the cost spent on agency staff vs dedicated staff and provided a list of

non-monetary benefits of hiring dedicated staff to care for the unique type of residents that we have and the continued efforts of other long term care facilities in the community to offer higher bonuses to new staff. Feedback from applicants reflect that salary is more of a priority than benefits such as pension and paid holidays. The Trustees were going to review the data and respond back to the DCNC Executive Team.
