Ms Nelson reported that the Center for Disease Control (CDC) preparing to release new guidelines; Centers for Medicare & Medicaid Services (CMS) has not made any changes. She did report that CMS is now requiring all facilities to have a full time infection control nurse; DCHC is in compliance. She provided an update on covid cases. She provided the forecast for the long term care industry including expected increases in census by 2024 and new potential guidelines from CMS. Responding to Trustee Rodgers questions, the infection control nurse works with the Health Department on emergency planning and is working on monkeypox policies & procedures.
