Board of Trustees Meeting Minutes for Monday, September 19, 2022

I. Call to Order Chair Borgeson called the meeting to order at 9:04 a.m. and stated that the meeting was being

conducted in compliance with Nebraska's Open Meetings law, a copy of which is located on the

back wall at Douglas Omaha Civic Center Building.

Chair Borgeson called the roll at 9:04 a.m. Chair Borgeson, Vice Chair Boyle, Trustees

Cavanaugh, Morgan and Rodgers were present for the meeting. Trustees Friend and Garcia

were not present.

II. Consent Agenda Chair Borgeson called for a motion to approve the Consent Agenda. Trustee Rodgers moved

VI. DCHC/CMHC Routine Reports

& Updates

a. Admin Update Erin Nelson is speaking.

Ms Nelson provided an update on the current guidelines provided by the CDC and CMS, the long term impact of the pandemic and changes to the long term care industry in the future. She provided an update for admissions and the census as well as FTE's. DCHC is currently experiencing a shortage of housekeeping and dietary staff due to an increase in market wages in the community but staffing levels for nursing have improved. Ms Nelson also reported on

the reutilization of office space on the 4th floor to a wellness area for the residents.

b. CMHC Routine Reports Sherry Driver and Chair Borgeson speaking.

Ms Driver provided an overview of the admissions process for the psychiatric inpatient program. She reviewed the medical screening process and the number of clients screened, provided the patient demographics both legal status and gender, the pay sources, a breakdown by age category of their clients (i.e.: 21-25 year old-9%) and the referral sources. She also provided discharge info including the length of the stay, primary and second diagnosis and where the client discharged to (i.e.: home-49%). Chair Borgeson requested a breakdown by zip

code of the referral sources.

Advance notice of the meeting was given by publication in The Daily Record, a legal newspaper. The notice advised that an agenda kept current was available for public inspection in the Office of the Administrator of Douglas County Health Center.
