a. Admin Update

DeDe Will and Jim Cavanaugh are speaking.

Ms Will provided a covid 19 updated for staff and residents and informed the Board that cases are slowly rising in nursing facilities throughout the state. She included an update on funding that is available and explained increases in Medicaid rates that were effective July 1, 2022. She also reported on the increase in behavioral health issues that long term care facilities have been experiencing. Ms Will included an admissions and census recap, occupancy by service type, current FTE data and gave an update on the River City Roundup Celebration held on September 27<sup>th</sup>. The residents enjoyed the food and all the activities especially the petting zoo.

Trustee Cavanaugh reviewed the funding available and the calculations used to provide the funding.
