##### a. Admin Update

Ms Will reported that the skilled nursing facility revalidation is indefinitely suspended and the federal nursing home mandate has been repealed. She provided an update on Netsmart billing for October and November. She advised that the plan of correction and required audits have been submitted to the Department of Health & Human Services (DHHS). DCHC Staff have been working with Public Properties to evaluate the windows on the west stack and plan funding for the 2026-2027 budget. Staff has also been working with DOTComm on fax, phone and cell phone service issues. Ms Will also provided an update on the census and provided staffing data on the average number of residents and hours and minutes per resident per day for the Nursing Department. DCHC exceeded hours and minutes compared to the rest of the state and the nation.

##### b. CMHC Update

Speaking is Sherry Driver.

Ms Driver provided an update on the new facility, the new NetSmart system and preparing for national accreditation. She announced that the DHHS has released the new service definitions. CMHC staff as well as the Nebraska Association of Behavioral Health Organization (NABHO) has reviewed the standards and has serious concerns regarding the new standards. They will be
